Again **100% of our resources are completely voluntary** and can be done in person, over the phone or other options. **Together we have over 270 trained first responder peers/CISM in the area including over 100 law enforcement and 100 fire & ems peers and a dozen 911 dispatchers.** Many have been through personal and agency traumatic events. In addition we have dozens of clinicians and programs that have been vetted to ensure they understand the first-responder culture.
